### Water and Sanitation dispatches water tankers in Free State. 01 April 2020.

"In an effort to fight the spread of the Coronavirus and ensure that the COVID-19 Curve is flattened, the Department of Water and Sanitation (DWS) has dispatched trucks (tankers) and tanks all over the Free State. On 22 March 2020 President Ramaphosa declared a shutdown of the country to curb the spread of the Coronavirus. DWS immediately started working on a plan to dispense water tanks and trucks to informal settlements and rural areas to strengthen the President's call to the washing of hands. 31 water trucks have been dispersed to Vrede, Fauresburg, Harrismith, Senekal, Clocolan, Petrusteyn, Cornelia, Villiers, Kroonstad, Viljoenskroon, Welkom, Bloemfontein, Thabanchu and Sasolburg."

Ministers release results of first round of public survey on the impact of Coronavirus COVID-19. 01 April 2020.

"The Minister of Higher Education, Science and Innovation, Dr Blade Nzimande, and the Minister of Health, Dr Zweli Mkhize, will release the results from the first round of the public survey looking at the impact of the COVID-19 on South Africans. On Friday 27 March 2020 – the Human Sciences Research Council (HSRC)- an entity of the Department of Science and Innovation - announced the launch the public survey to better understand what the South African public knows about Covid-19, the state of readiness to deal with this global pandemic and how they feel about

it. The company alleges to have been mandated by the Department to assist with the registration process of SMMEs who will be considered for opportunities to supply goods to Spaza shops and retailers nationwide. The organisation further claims to have been tasked to accept applications from SMMEs on behalf of the Department of Small Business Development during the COVID-19 National disaster."

# North West Economic Development on Coronavirus COVID-19 lockdown regulations and directives. 01 April 2020.

"In ensuring that businesses adhere to the Disaster Management Consumer & Customer Protection and National Disaster Management Regulations and Directives the Department of Economic Development, Environment, Conservation and Tourism through Consumer Affairs and Small Business Units conducted inspections within Mahikeng area. During the inspection, it was observed that most of the chain stores are still operating their open air food markets which is in-contravention of the regulations. For example businesses were found selling prepared foodstuffs like pap and vleis, pies and cooked vegetables which are regarded non-essential goods. The affected restaurants which were found operating were ordered to close as they were not compliant."

"Transport Minister Fikile Mbalula has announced revised regulations that call on the taxi industry to among others, reduce the number of passengers ferried per ride during the 21-day nationwide lockdown, implemented to curb the spread of COVID-19. He addressed the media at the Noord Taxi Rank on Wednesday, shortly after addressing traffic officers who have been deployed to ensure compliance with the published regulations during the lockdown. Under the regulations, passenger numbers are determined according to the licensed capacity of the vehicle."
