"South African Airways (SAA) will suspend all its domestic flights with effect from Friday, 27 March 2020.

"The decision came after government announced a nation-wide lockdown for 21 days aimed at combatting the spread of the Coronavirus (COVID-19)," it said in a statement on Tuesday.

The decision follows President Cyril Rampahosa's announcement on Monday, of a nationwide lockdown that will come into effect from midnight on Thursday."

## Disaster Management Act 57 of 2002

Directions made in terms of Section 27(2) by the Minister of Cooperative Governance and Traditional Affairs.

Purpose: "To direct municipalities and provinces in respect of the following matters in response to COVID -19:

- (a) Provision of water and sanitation services;
- (b) Hygiene education, communication and awareness;
- (c) Waste management, cleansing and sanitization;
- (d) Municipal public spaces, facilities and offices;
- (e) Customary initiations and cultural practices
- (f) Isolation and quarantine;
- (g) Monitoring and enforcement;
- (h) Municipal operations and governance;
- (i) Institutional arrangements and development of COVID -19 response plans; and
- (j) Precautionary measures to mitigate employee health and safety risks."

"Following the declaration of a nationwide lockdown by the President this past Monday, we have sat as the JCPS Cluster and the South African Police Service, to outline and intensify the measures we would be implementing to make sure that the intentions of this lockdown are realised. With the subsequent deployment of the SANDF, we will be increasing visibility and conduct integrated foot patrols, roadblocks, vehicle checkpoints as of 23h59 on Thursday evening 26 March 2020. Metro Police Departments as well as other Law Enforcement Agencies will form part of these joint operations that will be conducted for the duration of the lockdown. Operations, especially roadblocks will be conducted at sector policing level within communities and residential areas, on provincial and national roads. This will ensure that the movement of people and vehicles is kept to the minimum, with the exception of the transportation of essential good and/or services which include fire and medical emergency services."

Statement by the Minister of Sports, Arts and Culture on mitigation plans to minimise the impact of the Covid19 Pandemic on the Sector. 25 March 2020.

"President of the Republic of South Africa, His Excellency, MC Ramaphosa, in his address to the nation on the 15 March 2020, declared the spread of Corona Virus (Covid 19) a national disaster. This declaration necessitated the implementation of measures to mitigate the challenges. Amongst the measures announced by the President was to limit gatherings to less than one hundred people. This necessary measure was a fatal blow to the sector, since it depends on numbers for it to survive be it Gigs, Concerts, Sporting matches et al. We made the point at the time and we are reiterating now, that sporting and creative sectors are going to be the hardest hit by these critically important measures."
