# North West Health. MEC Madoda Sambatha visits Sibanye Stillwater Thembalani Shaft to monitor Coronavirus Covid-19 workplace lockdown regulations, 28 May. 28 May 2020.

"MEC Madoda Sambatha will today at 14h00 visit Sibanye Stillwater Thembalani Shaft (Bleskop, old Rustenburg road) to monitor compliance with workplace lockdown regulations. A total of 51 mine workers yesterday tested positive for COVID-19 taking number of confirmed cases to 53 at Sibanye. MEC Sambatha will meet with mine management to discuss way forward and case management. There are now 71 mine related confirmed cases in Bojanala. # SA Government News Agency. COVID-19 cases rise to 25 937, while WC records highest deaths. 2020 May 28 SA News

"COVID-19 cases have increased by 1 673 in the last 24 hours, bringing the total number of infections to 25 937 in the country. Meanwhile, the national death toll has risen to 552 after 28 more people succumbed to COVID-19 related illness, the Health Minister, Dr Zweli Mkhize, said in a statement on Wednesday. "We wish to express our condolences to the loved ones of the deceased and thank the health workers who treated these patients," he said. The Western Cape remains the epicentre, with 391 deaths, followed by the Eastern with 70, KwaZulu-Natal 49 and Gauteng 31. The Free States has six deaths, Limpopo has three, while North West and Northern Cape each have one. Mpumalanga is the only province that reported zero deaths. "The recoveries to date are 13 451, which translates to a recovery rate of 52%," Mkhize said."

# SA Government News Agency. DBE Minister assesses readiness for school reopening 2020 May 28 SA News

"Basic Education Minster Angie Motshekga says while most schools are ready for the reopening of schools to grade 7 and 12 learners - her department will not allow schools to reopen if the necessary personal protective equipment (PPE) is not available. The country's schools were prematurely shut on Wednesday, 26 March 2020, a day before government implemented a nationwide lockdown to curb the spread of the Coronavirus. With the country moving to alert level 3 of the nationwide lockdown, schools were directed to reopen following a decision taken by the National Coronavirus Command Council that the doors to learning reopen in a phased approach and under strict health conditions from the 1 June 2020 starting with grades 7 and 12."

- Assist businesses to access the necessary Personal Protective Equipment (PPE) by connecting them with suppliers through our PPE marketplace, and
- Identify and resolve systemic issues making it a challenge for businesses to implement the necessary safety measures to stop the spread of Covid-19."

Earlier on Thursday, the legal team representing Khosa's family rejected an inquiry report by the SA National Defence Force (SANDF), which apparently cleared soldiers of causing Khosa's death..."The report by the SANDF is rubbish. We do not accept it, the evidence completely contradicts this report. It is ridiculous to say he died of some other cause," Wikus Steyl, of Ian Levitt Attorneys, told News24 on Thursday."
